Editorial

President's Letter 2020

Dear EAA colleagues,

I write to you at a time when I had hoped we would be enjoying a post-covid Autumn, and looking forward to renewing our scientific collaborations and friendships that have been put on hold during the last 7 or 8 months of national "lockdown" in most European countries. However, many of us are now experiencing a second wave of the virus and have once more been returned to strict control over our ability to meet colleagues and travel internationally. Not surprisingly the biennial meeting of the EAA has had to be postponed until 2021 but we hope to occupy the same venue in Vilnius Lithuania at an equivalent time next year. The EAA Board is moving towards that target and we will keep you informed of the schedule as it evolves. It is unlikely, I think, that most people would be willing to commit to international travel until the spring of next year and thus I expect a decision to be made in about 6 months' time as to the viability of our late August meeting dates.

This Newsletter contains details of the results of Council and Board elections. My very sincere congratulations to all those who have been elected. I am humbled to have been re-elected as President for a second term of office and I look forward to working with you to promote anthropology in Europe. During the next two years there are four areas of focus that I believe are critical to the EAA. Firstly, it is vital to the future of the Association that we develop younger scientists and provide them with an open learned society in which they can discuss their research and obtain mentorship and advice from



those of us who have spent considerable time in the discipline and have broad experience of research and teaching. Secondly, it is important that we build a membership base that covers Europe and benefits from the cross-fertilisation of ideas from all parts of the continent. Thirdly, we need to make the EAA a society which offers value for money. Whilst the membership fee is low it is still incumbent on us to offer an academic environment in which our members will enjoy being actively involved. Fourthly, we need to ensure that the financial basis of the Association is strong and properly managed.

In the first instance I have appointed members of the Board to each of four sub-committees that will address these foci; young scientists, membership, future initiatives, and finances. The sub-committees will be able to co-opt whoever they feel will be useful to their remit from members of the Council and will meet virtually to discuss their ideas and develop recommendations for the Board. These will be

presented to the Board at the next meeting from which appropriate actions will follow.

It is my desire that the membership of the EAA feels that it can interact freely with the Board and Council to contribute towards our shared interest in anthropology and specifically the future of the European Anthropological Association. If you have comments and suggestions with regard to the four initiatives I have outlined above then please do not hesitate to make contact with the members of the Board to discuss your views.

It is with sadness that we record the passing of two eminent anthropologists. The Hungarian forensic anthropologist, Professor Ferenc Kosa, died in Szeged, Hungary on the 25th of July, 2020. In a career spanning more than half a century he made fundamental contributions to forensic anthropology for which he received international recognition. Our American colleague, Professor Francis Johnson, passed away on Thursday 20th August from the complications of Alzheimer's Disease. Frank Johnston was Professor Emeritus of Anthropology at the University of Pennsylvania, Philadelphia. His research focused on the growth and development of children, especially in relation to nutritional status and health. Obituaries for both these eminent anthropologists are included in this newsletter.

It is difficult to think of a future that will be Covid-free and will not involve a variety of different strategies to ensure safe infection-free meetings and collaboration. However, that time will come as we develop appropriate testing and vaccines and as research scientists develop an understanding of how the virus is spread and behaves in different individuals, communities, and nations. There is no doubt that the pandemic has caused us all to modify our working practices and many of us now

“work from home” as a standard practice. Lectures and tutorials are given in the virtual environment which, in my opinion, diminishes the learning opportunities and experiences offered by the face-to-face lecture theatre environment, but is an essential feature of current university life. The extra work involved in developing appropriate online lectures and learning materials has taken its toll on the time we have had to prepare our newsletter intended for earlier this year. For this I apologise but look forward to a more frequent correspondence in the next year.

Finally, I thank all those people who keep the EAA running on our behalf and especially our Secretary General, Professor Annamária Zsákai. My thanks also to Dr Rachel Deevey for organising and preparing the Newsletter.

Report of the General Secretary (2018-2020)

As the General Secretary of the European Anthropological Association my main duties were to manage the administration of the Association by following the Board decisions and the EAA regulations, and to manage the EAA website. Beside these tasks I undertook to open and manage a temporary EAA account. My secretarial activities between 2018 and 2020 can be summarised as follows:

1) The Council elections were performed online. The voting site was open only from the 7th of June (the number of EAA members was very small in the beginning of 2020, former members were asked about the renewal of their EAA membership and Local Treasurers were asked to help to recruit new members) and the elections were closed on the 28th of June 2020. A total of 61 members voted. On the basis of the voting results 31 members were asked to acknowledge being an EAA Council member for 2020–2022. Two members could not accept the Council membership due to their retirement, therefore the 32nd and 33rd members were invited, and finally 31 members accepted their Council membership. The EAA Council 2020-2022 takes office from the 28th of July 2020.

2) The members of the new Council were asked to state if they wished to be a candidate for a position on the new EAA Board by indicating which position they wished to apply for, and what kind of service they could offer as a Board member. The voting bulletin for EAA Board elections was finalised on the basis of the Council members' replies on the 28th of July 2020, and the voting site was open between the 10th and 20th of August. 87% of the Council members sent their votes for the candidates. Finally, the President and four Vice-Presidents were elected. The former President is automatically a member of the new Board, he serves as one of the Vice-Presidents between 2020 and 2022. The General Secretary was elected for 4 years in 2018. So, the Board 2020-2022 of the EAA is as follows:

General Secretary: Annamaria Zsakai

I thank Professor Elena Godina and Professor Esther Rebato, two members of the EAA Council 2018–2020, who served the Association through their inspector work in the online Council and Board elections.

3) A temporary account in Hungary was opened in 2019, since the former EAA account in Spain was closed. Without this temporary account the 2020 elections could not be organised, the new payments could not be registered.

4) As the General Secretary my task was to regularly contact the Organising Committee of the 2020 EAA Congress, to supply the Committee information on the EAA regulations, EAA members, etc.

5) It was also my task to help organise the EAA Student Award(s) for the Best Student Oral Presentation competition of the 2020 Congress. Two applications arrived by the extended deadline (the 30th of April 2020), however the applications have not been evaluated due to the postponement of 2020 EAA Congress.

6) I regularly updated the EAA website with news and information I received and found about the field of biological anthropology. I have to emphasise that this source of information is still very weak. My aim is to update the website with short videos and attractive photos of our social life to draw attention of potential new members to the Association.

I would like to express my gratitude to the Local Treasurers who provided me with payment information, and also to Professor Noël Cameron, EAA President, and Professor Nicholas Mascie-Taylor, EAA Vice-President, for their collaboration and support.

EAA Board Meeting Report

EAA Board Meeting (online Teams meeting, 30th June 2020)

1. Postponement of 2020 Congress in Vilnius (Lithuania) to 2021

Prof. Janina Tutkuvienė announced the postponement of the 2020 EAA Congress due to the COVID-19 pandemic to August 2021. The postponement has been announced on the official website of the Congress and on the official EAA website as well. The President of the Organising Committee emphasised that their aim was to maintain the original program, to accept new abstract submissions. She stated that the registrations, which have been paid, are valid for EAA Congress 2021. New deadlines for abstract submission and registration will be available soon. Based on the registrations in 2020 she expects 130-140 participants in the 2021 Congress. Prof. Tutkuvienė was very successful in finding financial support for Congress 2020, however the support was available only for the congress to be held in 2020, so her aim is to apply for financial support for the Congress 2021.

Prof. Noël Cameron suggested to organise a 'Meet the Professors' session for the student participants in 2021 Congress.

2. Venue for 2022 Congress

The EAA Board has received only one application for the 2022 Congress, the application was submitted by Prof. Yilmaz Selim Eral from Turkey for a meeting to be held in Ankara. The EAA Board has not yet decided the venue of the 2022 Congress. Prof. Erksin Gülec asked the Board about the main reasons, since only one application arrived. The other members of the

Board agreed that the time was not appropriate to go to Turkey. It was suggested to raise this question in 6-9 months and to make a final decision then. Prof. Cameron suggested to establish a subcommittee to facilitate this unsolved situation, to help the Board to make its final decision on 2022 Congress and to stimulate potential congress organisers of 2024 Congress.

3. Financial support for biennial meetings

It was proposed to offer up to 5000 Euros pre-congress support as a loan to EAA Congress organisers. Depending on the financial situation (on the amount of support from agencies and funds) the repayment of the support after the congresses would be acceptable. The suggested support amount was accepted for transfer to Prof. Tutkuvienė for the 2021 Congress.

4. Financial report

A. Zsakai reported that the balance of the former EAA account in Spain was 38,009.7 Euros in June 2020. The balance of the temporary EAA account in Hungary was 1290.41 Euros in June 2020.

5. Future banking arrangements

The official EAA bank account is still problematic. A. Zsakai offered to explore the requirements of opening an EAA account in Hungary. The preliminary information from the Hungarian banks raised the possibility of opening one in Hungary (OTP Bank), however the founding document of the EAA from 1976 is required to open such an account. The document has not been found as yet.

6. EAA General Treasurer position

The GT position is still open and the lack of an official account aggravates this situation. The Board suggested to elect/co-opt an Adjunct-Treasurer(-Secretary) from the same country as the GT (as soon as the GT post is filled).

7. EAA Council and Board elections, online meetings of the new Council and Board (2020-2022) in 2020

A. Zsakai reported that the voting phase of the Council elections closed on 28th June 2020. The EAA has altogether 182 members who could vote and 61 (33.52%) sent in their votes. The voting process and the results were checked by two members of the Council: Prof. Elena Godina (Russia) and Prof. Esther Rebato (Spain). The Board checked the results and the first 31 members from the list were contacted and asked about their intention to accept Council membership and to apply for a Board position. The potential Council members were contacted on the 1st July, at the end of July the voting Bulletin for the Board elections could be finalized. The new Council (2020-2022) is announced in this newsletter. The new Council meeting was held on 28th July 2020.

1. Apologies for absence

The General Secretary reported apologies for absence of Council members. Altogether 16 members of the Council were present at the meeting, so the President announced that the 2020 Council online meeting was quorate.

2. Report on the EAA Council Elections

The General Secretary reported that the new Council formed on the 28th July 2020, comprised 31 members after taking account of the voting,

the replies of potential Council members and the regulations of the EAA. The members of the Council 2020-2022 were asked to say if they would like to put their name forward for a Board position that started at the beginning of August. The detailed report on the Council elections can be found on page 5.

3. Report of the President

The President thanked the members of the EAA Council for their attendance in these difficult times. He emphasised the deleterious effect of the Coronavirus pandemic on the usual business of the EAA. He reported that he had worked closely with Professor Tutkuvienė to reschedule the congress for 2021 but was mindful that it may well be that another postponement may be necessary. Professor Cameron was keen to tackle three aspects of the EAA moving forward; the organisation of the finances into an international bank account, a drive to increase membership, and an initiative to attract young scientists and researchers. He would be paying particular attention to these aims during his next term of office. He thanked Professor Annamaria Zsakai for her hard work and commitment to the EAA.

4. Report of the General Secretary

The General Secretary reported on her work for the 2020 elections, the management of the EAA payments and the management of the EAA website (the report can be found on page 5). She expressed her thanks to the Local Treasurers, to the Board members and the two inspectors of the elections, all of whom helped her work in collecting information on EAA memberships, payments and events.

5. Financial report

The financial report was presented by the General Secretary. The report was based on the information sent by Prof. Pilar Montero, the former General Treasurer of the EAA and on the balance in the temporary EAA account. The actual balance of the EAA accounts is: 38,009.7 Euros in the former EAA account and 1290.41 Euros in the

temporary account making a total of just over 40,000 Euros.

6. Report on the EAA Newsletter

The changes to working practices throughout Europe caused by the Coronavirus pandemic had prevented appropriate copy being developed for the early 2020 Newsletter. However, a current newsletter was in preparation and would be distributed in the near future.

7. Postponement of 2020 Congress in Vilnius (Lithuania) to 2021

Prof. Janina Tutkuvienė summed up the history of the Vilnius Congress and the final process of postponing the meeting until 2021. The Organising Committee gained sufficient financial support for running the meeting and more than 80 members had already submitted their abstracts for the scientific meeting. But finally, due to the COVID-19 lockdown, the Organising Committee decided to postpone the congress until August 24-28, 2021. All information on the 2021 Congress can be found on the official website of the Congress. Prof. Tutkuvienė announced that the original program proposed for 2020 will be held in 2021, new abstract submissions will be accepted and already submitted abstracts can be changed, and the registration fee will remain the same for 2021. She stated that if the Organising Committee generates sufficient financial support the registration fee of student members will be reduced. Prof. Tutkuvienė was warmly thanked for taking the initiative to move the meeting forward to 2021 and congratulated on raising funds for the 2020 meeting which it was hoped could also occur in 2021.

A special section for students (covering for example - meeting the professors, how to publish in anthropology, how to get experience in teaching, careers in anthropology) was suggested by Prof. Cameron to be organised for the 2021 meeting.

8. Venue for 2022 Congress

The Council discussed the possibilities of the 2022 Congress venue, but it was not clear whether it could be planned for 2022 in the current COVID-19 situation. Hopefully, the 2021 Congress will be held successfully, and the Association can plan for its 2022 Congress, but several members of the Council suggested caution in organising EAA activities and works over the next few years due to uncertainties over COVID-19. However, it was also suggested that a loan could be made to prospective congress organisers of up to 5000 Euros to support set-up costs and renting of rooms etc. with the aim that the loan would be paid back to the EAA after the Congress. Finally, Prof. Cameron suggested the formation a sub-committee of the EAA Board to promote active liaison with potential Congress Organisers.

9. Future banking arrangements

The EAA does not have an official bank account in its own name. A. Zsakai offered to get information on the opening of such an official account in Hungary and to prepare the requested documents from the Association.

10. EAA General Treasurer position

This position is still open, it was not offered for application in the 2020 Board election. As soon as the EAA has its official bank account, the position will be announced. It would be important and efficient if the General Treasurer comes from the same country as the General Secretary. This would help their common work with the management of the membership payments and the EAA account.

Obituaries


Frances E Johnston PhD

Professor Emeritus of Anthropology, University of Pennsylvania

It is with the greatest sadness that we announce the death of Professor Frances E Johnston. Frank Johnston passed away peacefully on Thursday 20th August from the complications of Alzheimer's Disease.

Frank Johnston was Professor Emeritus of Anthropology at the University of Pennsylvania, Philadelphia. He had been an Overseas Fellow of Churchill College, University of Cambridge (1994-95 and 2000), a postdoctoral Fellow at the Institute of Child Health, University of London (1966-67, 1988-89) and the Institute of Cancer Research, Philadelphia (1967-68), Visiting Fellow of the Department of Anthropology, University College, London, (1988-89) and Visiting Professor of Human Biology at the University of Cape Town (1989).

Frank Johnston's research focussed on the growth and development of children, especially in relation to nutritional status and health. He worked extensively throughout Latin America, especially Guatemala (since 1966) but also in Mexico, Peru, Ecuador, and Cuba.



He has also been involved in the study of the health effects of modernisation in Papua New Guinea liaising with Professor Barbara Honeyman-Heath-Roll. In 1982 he was the Gallagher Lecturer of the Society for Adolescent Medicine and in 1986 he received the award as author of the best article appearing that year in the Journal of Adolescent Medicine.

Since 1990, Johnston has been active in academically-based community service initiatives in West Philadelphia where he founded and directed the Urban Nutrition Initiative. He was a Distinguished Fellow of the University of Pennsylvania Center For Community Partnerships and co-Chair of its Faculty Advisory Committee. He was also a member of the U. of Pennsylvania Medical School Council on Health Promotion and Disease Prevention and the Council's Special Task Force on improving the health status of the West Philadelphia community.

Frank Johnston was a past-President of the American Association of Physical Anthropologists (1983-85) and was Editor-in-Chief of the American Journal of Physical Anthropology (1977-83), Human Biology (1987-88), and Founding Editor of the American Journal of Human Biology (1988-90). He served as Consultant to the National Academy of Sciences, the National Science Foundation, the National Institutes of Health, the World Health Organization, and the Pan American Health Organization. In 2003, Johnston received the Charles Darwin Lifetime Achievement Award of the American Association of Physical Anthropologists.

Frank Johnston was a gifted teacher enthusing graduate and undergraduate students with the depth and breadth of his interest in his research. He was an unofficial mentor to many current senior anthropologists always willing to share his advice based on long experience of teaching and research at the highest levels. He had sharp intelligence and encyclopaedic knowledge of human growth and development transmitted to audiences, colleagues, and students with a beguiling manner.

We will miss his presence in our academic lives but are enriched by his contributions to our knowledge.

[Prof. Ferenc Kosa \(1935-2020\)](#)

Prof. Ferenc Kosa was born in Bekescsaba (Hungary) on the 13th of April, 1935. He started his higher education in the Faculty of Medicine of the Medical University of Szeged in 1953. His student work on dermal cancers was awarded in 1958. He obtained his medical degree as summa cum laude in the same year.

After his higher education Prof. Kosa started his work in the Institute of Forensic Medicine, Szeged, Hungary as a research fellow (between 1959 and 1961), then worked as an assistant between 1961 and 1966, as an assistant lecturer between 1966 and 1974, as an associate lecturer from 1974 and as a professor after all. He served as a vice-director of the Institute between 1967 and 1973 in the directorship of Prof. Gyula I. Fazekas. He graduated in forensic medicine in 1963, awarded CSc degree in medicine in 1971 and DSc degree in medicine in 1991.



During his university years he married his classmate, Ms Klara Biro, who graduated as a paediatrician and otolaryngologists. Their son, Zsolt graduated as a gynaecologist, while their daughter as a biology and technology teacher.

He gave lectures and led practical courses in Hungarian for both medical and dentist students, and also in English for foreign students from 1989. In 1992 he wrote the textbook titled Compendium for Forensic Medicine. From 1968 he supervised 10-15 students' congress works and 35 students' diploma work.

His work concentrated on the supervision of judgements in the Forensic Medical Institute as well as on the scientific leadership of origin determination and criminal laboratory in the Institute.

His scientific interest covered medical law, medical ethics, forensic and paleoanthropological osteology, serologic and criminalistic laboratory examinations, histology, biochemistry and immunochemistry of vital injuries.

Prof. Kosa's publication activity includes more than 200 articles, 1 scientific book, 4 book chapters and several university text books.

Prof. Kosa's scientific work was awarded by the Public Safety Gold Medal (1972), Thomasius Plaque (Halle, Germany, 1978), Home Service Gold Medal (1979, 1987), Purkinje Plaque (Prague, Czech Republic, 1988), the Award for Excellent Work (1989), and the Gold Ring of Ministry of Interior (1989).

Prof. Kosa's scientific and public work also manifested in his memberships of several national universities and ministry committees. He served as opponent, member of the review board or secretary in the Biology Review Board of the Hungarian Academy of Science.

He was member of 9 Hungarian and 11 international scientific associations. He had 16 research trips abroad (German Democratic Republic, Poland, Bulgaria, Czechoslovakia, England, Finland, USA). He gave lectures at 24 international congresses abroad.

Prof. Kosa's scientific work was important in biological anthropology as well. He published several papers in biological anthropology with his co-authors, and reviewed dissertations and applications. Along with his activity in the Hungarian biological anthropological congresses, his invited lecture in the congress of the American Association of Physical Anthropology in 1990 was also a milestone in his career.

In 1991 he was awarded a 3-month long scholarship in the Department of Anthropology, Smithsonian National Museum of Natural History, Washington DC, USA. During his research trip Prof. Kosa studied foetal bones in Washington.

Prof. Kosa served as a member of the anthropological committees of the Hungarian Academy of Sciences from 2001.

The Hungarian anthropological community is very grateful for Prof. Kosa's tremendous work in biological anthropology.
